1. INFORMATION OF INTEREST

- The Comercializadora de Servicios Médicos Cubanos, S.A. (CSMC, S.A.) is the entity authorized to commercialize academic health services in Cuba.
- This announcement is for **self-financed studies** in the different forms of postgraduate studies in the health sciences.
- The postgraduate academic training in health for foreigners includes training in more than 50 medical specialties, 5 stomatological, 4 nursing and one in Health Psychology, as well as more than 40 masters and doctoral programs in health sciences.
- Professional upgrading integrates a set of processes that enable university graduates to acquire and continuously improve their basic and specialized knowledge and skills.
- Cuba has 13 universities of medical sciences that offer the possibility of providing postgraduate training and professional development.
- These academic institutions are under the direction of a Rector and with a categorized faculty, in certified scenarios, which gives them the right to issue university certification documents at any level.
- The number of vacancies in the specialties are planned for the current year of the announcement and not by periods, so that the locations are provided as the client requests them and can be completed for a particular location before the end of the year.
- The teaching and assistance services have a limit of vacancies for resident studies and we cannot exceed it. We are not obliged to assign the applicant where he/she requests it if the place is not available.

- In Cuba there is a National Accreditation System, by means of which the teaching scenarios are certified in order to guarantee compliance with the activities described in the study programs.
- The training curricula are unique for the whole country and their implementation is carried out equally for all students.
- The addition of contents and objectives in the study program is allowed, prior conciliation with the university authorities and the Comercializadora de Servicios Médicos Cubanos (CSMC) as a principle and so that the degree can be validated where the applicant is going to practice.
- Professionals with previous studies in the requested specialty are allowed to validate the contents of the study program and therefore, reduce the time, as long as they present the relevant supporting documents and the university authorities so determine. This process involves an additional payment.
- Studies in Cuba are in Spanish. For non-Spanish speaking students, we offer Spanish language courses at the universities of Medical Sciences.
- The only ways of payment allowed are bank transfer and online payments through payment gateways.
- The prices of this announcement are expressed in US dollars (USD), being the reference currency, although bank transfers in USD are not allowed. You must pay the equivalent of the price expressed in an international currency such as Euros, British pounds, Canadian dollars, among others.
- Once the tuition payment has been made, it is non-refundable, regardless of the cause of cancellation of studies.
- Failure to make the payment on the due dates means the non-continuation of the studies, which may lead to the cancellation of the contract if it is an unjustified and reiterated action. Any damage caused to the student's education as a result of this situation is the total responsibility of the student.

• The payment made is for years of study, so that the removal of content for validation or proficiency exam, or by advancement or reduction of study time as stated in the postgraduate regulations, do not involve refunds of the amount paid.

2. PERSONAL APPLICATION FOR STUDIES

- Applications will be received throughout the year by e-mail at docencia@smcsalud.cu.
- For this announcement, the specialties, officially, have two course starts, in September 2023 and January 2024. Admission in either of the two periods will depend on the applicant's reasons and he/she must inform when he/she will start when sending the acceptance of the awarded location. If for any other reason, it is not possible to join in September for those who so defined, they can join in January, keeping their same location.
- If the client needs to be incorporated at a time other than those mentioned above and within the same call, he/she must inform the corresponding university for authorization.
- Once the client agrees with the terms of this current call, he/she will proceed to send only the following documents:

1. Application form (Annex 1).

- 2. Reverse Curriculum Vitae (reflecting the most recent data, both the latest professional experiences and the last degree obtained and continue with the rest of the trajectory from the most current to the oldest, in addition to photo, personal or contact information, skills, languages and other data of interest).
- In case you are applying for a professional development activity, you must fill out the application form for that modality (Annex 2).
- The forms will be filled out digitally (not handwritten) and it is mandatory to fill out all the fields it contains. Incomplete documents will be returned to the client.
- The application process is free of charge for the client.

- The granting of the scholarships is at the discretion of the universities, which reserve the right of admission.
- The client will receive via e-mail a letter of acceptance in response to his application within 30 days. It is obligatory for the applicant to confirm acceptance of the place within 72 hours to ALL the e-mail addresses indicated in the acceptance letter.
- There may be some applications that, due to force majeure, exceed the established response time and CSMC, SA reserves the right to inform the client accordingly.

3. PREPARATION OF YOUR TRIP TO CUBA:

Having the letter of acceptance, the client begins the preparation of his study trip.

Before defining the travel date, the client must take into account:

- 1. Documents required to be presented at registration.
- 2. Start date of the academic year.

<u>Documents required for enrollment</u> that must be duly legalized by the Cuban diplomatic representations abroad:

a) Photocopy of the **Professional Degree** duly legalized. Foreign citizens who have not obtained their higher education degree in a Cuban higher education center must present the original degree legalized by the Cuban Embassy in the country where it was obtained, legalize it at the Cuban Ministry of Foreign Affairs and subsequently present it to the Legal Department of the Ministry of Higher Education for its recognition or validation. The above is a requirement to be accepted as a student in the program. If necessary, an official translation into Spanish, also legalized, must be included.

- b) The data appearing in the official document is the obligatory reference to verify the legality of all documents presented by the applicant and all official documents issued by the institution will be made by this document.
- c) **Curriculum Vitae.**
- d) Photocopy of the transcript of **Grades of the Caree**r in which he/she graduated, in the case of academic training activities, duly legalized at the Embassy of the Republic of Cuba in the country of origin or residence.
- e) **Health certificate** that includes a declaration that he/she does not carry transmissible diseases and specifically the Human Immunodeficiency Virus (HIV), as well as physical or mental impediments disabling for the exercise of the profession to which he/she aspires and in the case of females, a certificate that assures that she is not pregnant. This document is valid for 3 months from the date of issue.
- f) Ten (10) 1x1 inch photos.
- g) Document that certifies that he/she **does not have a criminal record.** This document is valid for 3 months from the date of issue.
- h) Birth Certificate.

Other required documents:

- a) Evidence of admission to the career issued by the university that approved the same (Letter of Acceptance).
- b) Receipt of payment corresponding to the tuition fee and the first installment of tuition.
- c) Cuban Health Insurance purchased from the health insurance company ASISTUR, which can be purchased prior to or within a week after arrival in Cuba. If the student has any, he/she can bring it and ASISTUR will determine if it is valid and/or compatible with those offered by ASISTUR.

The **starting period of the academic year** begins in September and in January of the next year. There is flexibility in graduate enrollments and if a client has a

specific situation that does not allow him/her to comply with the term, he/she informs us and we ask the university to authorize his/her late entry, which is possible.

The client must arrive in Cuba at least 10 days before the beginning of the academic year for the corresponding procedures: International Health Control (mandatory), immigration procedures, preparation of identity card and medical insurance.

The **Spanish c**ourse has two editions during the academic year: February and September and lasts 20 weeks.

4. APPLICATION FOR AN ACADEMIC VISA

Once the client has been accepted by one of our study centers, he/she can apply for an academic visa for entry into the country.

The following documents must be sent to us at docencia@smcsalud.cu:

- 1. Academic visa application form (Annex 3).
- 2. Letter or document of acceptance for the studies of the centers of studies in Cuba.
- 3. Confirmed airline ticket for the trip

Applications must be made at least 60 days prior to the date of travel.

Once the application is approved by the Cuban immigration authorities, an authorization is sent to our embassy in the country of residence to issue the visa. The client applies at the Cuban embassy for the visa once the authorization arrives. If the academic visa has not been granted before traveling, the student may travel with a tourist visa and make the change of immigration status upon arrival, which costs 960.00 CUP in stamps, and obtain the identification document issued by the Immigration and Foreigners Office of the Republic of Cuba, which costs 240.00 CUP.

The price of these insurances depends on age, sex, pre-existing diseases, among others.

There are health insurances acquired in the country of origin or in other countries that can be validated with ASISTUR's insurances, which is the only entity authorized to determine their validation or not.

6. PRICES OF THE SERVICES:

- The registration fee is 1,000.00 USD for all medical, stomatological and nursing specialties and this value is independent of the prices of the specialties and must be paid at least 15 days before your arrival.
- In addition to the registration fee, the price for each academic year is established according to the classification groups of the specialties and can be transferred in full or in installments.
- If at the beginning of the course the payment of the corresponding installment has not been made, the enrollment or continuation of studies will not be official, which implies the loss of the right to participate in the teaching activities in all their organizational forms.
- The prices of academic services include:
- Right to attend all teaching and optional activities, both theoretical and practical,
- Right to all exams, including the final state exam.
- Certification of grades for academic periods and the final.

DOCTORAL PROGRAMS

- Applications for doctoral programs should be sent to the following e-mail address: docencia@smcsalud.cu.
- The main requirement for admission to a doctoral program is to hold a university degree and to attach to the application a brief description of the proposed research topic.
- Applications will be approved by the Universities of Medical Sciences appointed as institutions authorized to prepare doctoral degrees in a given field of knowledge.
- The research topics will be related to scientific problems of the doctoral candidate's country of origin, although exceptionally, depending on the case, and with prior authorization, the research may be carried out in Cuba.
 Once your application has been approved, you will be informed electronically to initiate the necessary procedures.
- The doctoral programs use a system of obligatory and optional credits according to the achievement of their objectives and the individual training needs of the doctoral students and are in accordance with the current regulations established by the National Commission of Scientific Degrees of the Republic of Cuba.

Instruction No. 1/2020 of the President of the National Commission of Scientific Degrees stipulates that foreign doctoral students must remain in Cuba for one year, which may be modified in accordance with the aforementioned regulation, depending on how the requirement of two scientific publications of the essential content of the thesis prior to the defense in publications included in any of the accepted regional and international indexing systems and abstracts (Resolution 1/2020) is fulfilled, if both publications are evaluated at the maximum in the area of knowledge of the program, the time will be 90 days (three months) if one is evaluated at the maximum and the other at the minimum, 180 days (six months)

and 365 days (one year) if one is evaluated at the maximum and the other at the minimum.

The degree that can be obtained, depending on the research topic and the program in which the student is enrolled, is as follows

- Doctor of Medical Sciences
- Doctor of Stomatological Sciences
- Doctor of Health Sciences
- Doctor of Medical Education
- Doctor in Nursing

The doctoral program has a total cost of 12,000.00 USD, divided in different moments:

- 1. Tuition: 1,000.00 USD, once your registration has been accepted by the Academic Committee.
- 2. Examinations of proficiency in the contents of social problems of science and technology and foreign language (approved languages for Spanish speakers: English, French and German). The fee for each exam is 1,500.00 USD (total of 3,000.00USD).
- 3. Pre-defense: 1,500.00 USD.
- 4. Defense: 2,500.00 USD.
- 5. Tutoring and counseling of 4,000.00 USD to be paid in two equal installments of 2,000.00 USD each. The first one during the first 30 days after the registration of the program and the second one before the pre-defense.

All payments will be made by bank transfer, with a prior time of 30 days before the scheduled activity, failure to comply with these according to the times in the training, will determine the non-continuation of studies and / or cancellation of the contract.

PROFESSIONAL DEVELOPMENT ACTIVITIES

- The main ways of professional development are courses, trainings and diploma courses, although they are not the only ones.
- To request a professional development activity, the client must provide their training needs and/or practical skills they wish to develop, as a first requirement.
- The client must define the period in which he/she wishes to carry out the
 professional development activity, unless he/she is applying for diploma
 courses and trainings that are by editions, which he/she would be
 previously informed.
- We have a group of professional development programs approved by universities, which we offer to the client depending on their learning needs.
 In the case that we do not have an approved option, we send the request to the university so that its academic committee can propose and develop a program tailored to the client's needs, if applicable.
- The request for a service is made through the following documents:
 - o Application form (Annex No. 2).
 - o Curriculum Vitae
- The university will issue a letter of acceptance as a positive response to the client. In cases of denial, reasons will be given.
- Prior to the start of the program, the client is required to make full payment for the program. Payments in installments are not accepted in this modality.

7. GENERAL ASPECTS OF PAYMENT FOR SERVICES

- All the services we offer are prepaid. The client is required to present proof of payment at the time of registration.
- Cash payments are not accepted.

- A discount of up to three percent (3%) of the value of the academic year is authorized if full payment is made before the start of the academic year.
- Payments must specify the full name of the student for whom the payment is intended, as well as the University of Study and the academic service being paid.
- The frequency of payment is annual, before the beginning of the academic services and in full or in installments.
- The legalization of documents at the MINREX for use abroad is not included in the tuition payments, it will be done personally by the student and at the student's own expense.
- Once the enrollment is made official, a contract will be signed between the student, the University and the corresponding branch of the Comercializadora de Servicios Médicos Cubanos. If the student does not show up for the agreed academic services, 10% of the agreed amount will be deducted.
- If the student is late in the development of his academic program, for reasons not related to the institution, he may submit a request for extension to the authorities of his university, which would be analyzed and if approved, he shall pay the amount calculated on the basis of the extra time to be extended. Similar treatment will have the addition of contents and/or objectives to the study program due to the student's interest.
- Graduates of Cuban universities of medical sciences, exceptionally, shall be

9. OTHER GENERAL ASPECTS OF IMPORTANCE:

- The programs of the specialties cannot undergo variations by default in terms of time and contents. It is possible to add time or hourly classes and contents at the request of the applicant by written request at least 45 days before the final exam of the 1st year and after analysis of the group of experts appointed by the Rector of the University of Medical Sciences where he/she will study. The applicant must pay the payment corresponding to the time and/or contents added according to the technical opinion. There is no possibility of eliminating time or contents declared in the study programs of each specialty.
- The programs of the specialties are not sent prior to your arrival and official registration. Only general information about the specialty is sent at the student's request, but never the complete curriculum. Upon arrival, the student has the right to know the modules, terms and the evaluation system that make up the program of study of the specialty that the student will study.
- If the student is diagnosed with any of the disabling diseases described in this document during or after the International Health Check-up, he/she will be suspended from teaching activities and must return to his/her country immediately. If the illness is curable, the student may return as long as he/she presents a medical certificate legalized by the Cuban embassy in his/her country of origin or residence, which certifies that he/she is cured. In any other case, readmission will not be possible.

- If once the studies of the specialty chosen by the student have begun, he/she decides to change specialty and there are vacancies in the same, he/she has the right to make the change within the first three (3) months of the beginning of the studies. To request the change, he/she must make it in writing to the Postgraduate Department of the center where he/she is studying, with a copy to the Postgraduate Department of the Academic Coordination of the University of Medical Sciences and to the Academic Services Directorate of Servicios Médicos Cubanos, S.A. and wait for the opinion of said institutions. To start in the new specialty, he/she will have to pay again 1,000.00 USD for the registration fee of the new specialty. If the specialty to which the student transfers to is a higher rate group, he/she must pay the difference before starting the same, but if he/she transfers to a lower rate group, he/she does not receive reimbursement that year and only from the following year onwards he/she pays the corresponding amount for that academic year with the corresponding discount of what he/she paid according to the group in which the new specialty is classified. After 3 months and one (1) day have elapsed, he/she will not have the right to request a change of specialty.
- In order to transfer from one University of Medical Sciences (UCM) of a province
 to another, the student must send a written request to the Rector of the UCM
 where he/she is located and from there the possible transfer will be consulted
 to the Teaching area of the Ministry of Public Health, where it will be decided if
 the transfer is possible or not.
- If the student leaves the program (academic, due to personal problems, illness or others) in a period of less than 50% of the time declared in the program of studies for the agreed academic activity, the student is entitled to a reimbursement of 40% of the payment made for such concept, **except for the tuition**. After 50% and one (1) day of the time declared in the program of studies for said activity has elapsed, the student shall not be entitled to any reimbursement. The above does not exempt the student from the payment of

any other acquired economic responsibility. If the withdrawal is the result of violations of discipline or non-compliance with the Regulations of the Residency Regime of the Ministry of Public Health and Regulation No. 26-2012 for foreign students established by the Ministry of Higher Education (MES), no reimbursement will be made. If the withdrawal is the result of a diagnosis of any of the disabling diseases declared in this document or pregnancy, the student will not be reimbursed and must return immediately to his/her country of origin or residence.

- If the student leaves the program for any reason **during the first week** after the time declared in the program of studies for professional development: courses, training, internships, diploma courses, or the first month of those corresponding to academic training: specialties, masters and doctorates, 10% of the total payment made for academic services will be deducted.

If the illness is curable, he/she will be able to return as long as he/she presents a legalized medical certificate attesting to the cure. In any other case, readmission will not be possible.
- If the client is a carrier of an illness that invalidates him/her to study in Cuba, he/she must return immediately to the country of origin, applying the discount regulations established for this purpose.
